
**MOTION FOR EXTENSION OF TIME
TO FILE REPLY TO MOTION FOR
DEPOSITION OF DR. DAN FISCHER
AND SAM BROWER**

13 COMES NOW, the State of Arizona, by the Mohave County Attorney, and hereby
14 moves the Court to allow the State one additional week to file responsive pleadings to
15 the Defendant's Motion for Deposition of Witnesses, Dr. Dan Fischer, and Sam Brower.
16 The reason for the request is that both of these witnesses are Utah residents who have
17 Utah attorneys that have an interest in this battle over whether or not attorney-client
18 privilege applies or not.

19 Dr. Fischer is represented by Utah Attorney, Randy Dryer. Sam Brower is
20 represented by Utah Attorney, Roger Hoole. In particular, Attorney Randy Dryer
21 indicated that he just saw defendant's motion for the first time on Monday, August 25,
22 2009. Both attorneys would like a little additional time to file responsive pleadings and
23 possibly retain local counsel so that they can appear pro hac vice. The State is
24 requesting just one additional week to file the responsive pleading that would have been
25 due on Monday, August 31, 2009. The State has contacted defense counsel, Michael
Piccarreta, and he has no objection to the motion for extension of time for one week.
