WARNING TO DEFENDANT

You have the right to be present at your trial and a number of proceedings of which you will be notified. If you do not appear at the time set by the Court, a warrant will be issued for your arrest and the proceedings will begin without you.

CONSEQUENCES OF VIOLATING THIS ORDER

If the Defendant violates any conditions of this release order, the court may order the bond and any security deposited in connection therewith forfeited to the State of Arizona.

In addition, the Court may issue a warrant for the Defendant's arrest upon learning of the violation of conditions of release. After a hearing, if the Court finds that the Defendant has not complied with conditions of release it may modify the conditions or revoke the Defendant's release altogether.

If the Defendant was released on a felony charge and the Court finds the proof evident or the presumption great that the Defendant committed a felony during the period of release, the Court SHALL revoke the release. Such Defendant would also be subject to an additional charge, and upon conviction could be punished by imprisonment for not more than five years in the state prison, in addition to the punishment which would otherwise be imposed for the crime committed during the period of the release.

Upon finding that the Defendant or any other person named in this order has willfully violated its terms, the Court may also find the Defendant or other person in Contempt of Court and sentence that person to a term of imprisonment, a fine, or both.
