2 Utah State Prison at Draper, Utah.

4           With regard to the Certificate of Inmate Status (Standard IAD Form III),  
5 Inmate Jeffs is submitting this Supplement to his Notice of Place of Imprisonment  
6 and Request for Disposition of Indictments, Informations, or Complaints to the  
7 Warden at the Utah State Prison at Draper, Utah, along with a copy of his original  
8 Notice of Place of Imprisonment and Request for Disposition of Indictments,  
9 Informations, or Complaint, which is incorporated herein by reference, and is  
10 requesting the Warden to complete the Certificate of Inmate Status.

14 Inmate Jeffs provides the following:

15           1.     The inmate's commitment offense(s): two counts of rape as an  
16 accomplice in violation of Utah Code Annotated §§ 76-5-402, 76-5-406(11) and  
17 76-2-202 (1953, as amended).

19           2.     The term of commitment under which the inmate is being held:  
20 two terms of not less than five (5) years and which may be for life, to be served  
21 consecutively to each other, with credit for time served.
