APPEARANCES: Matt Smith, Deputy County Attorney; Michael L. Piccareta and Richard A. Wright, Attorneys for and with the Defendant; Roger H. Hoole, Attorney, appearing telephonically.

This is the time set for Omnibus Hearing. The Court is presented with the Omnibus Hearing Form; discussion ensues as to the issues set forth therein.

Mr. Piccareta advises the Court that the parties have agreed upon the following; Motions will be filed by August 13, 2010, responses filed by August 27, 2010, replies filed by September 3, 2010 with a hearing date set by the Court on those motions. Motions in Limine will be filed by September 17, 2010, responses filed by September 24, 2010, replies filed by October 1, 2010 with a hearing date set by the Court thereafter.

Mr. Smith has no objection to the time frame outlined by Defense and requests a trial date set in CR-2007-0953 first.

As to cause number CR-2007-0953:

IT IS ORDERED setting this matter for Jury Trial on Tuesday, November 2, 2010 at 9:30 a.m.

IT IS FURTHER ORDERED setting this matter for a Final Management Conference and Hearing on Motions in Limine on Friday, October 8, 2010 at 8:30 a.m.

All parties agree to defer setting a trial date in CR-2007-0743 until after the trial is complete in CR-2007-0953.

IT IS ORDERED directing Counsel to submit to the Court for its signature an Order setting forth the dates that have been agreed upon.



IT IS FURTHER ORDERED that the Court will defer scheduling a firm trial date in CR-2007-0743 until the completion of the trial in CR-2007-0953, or subject to request by either counsel.

Mr. Piccarea requests a hearing set for argument on motions, where pleadings will be completed by September 3, 2010.

IT IS ORDERED setting this matter for Hearing on Substantive Motions on Friday, September 10, 2010 at 8:30 a.m.

Mr. Piccarea advises the Court that the parties have agreed that the State will release original medical records of [REDACTED] to Defense or a designee, should something happen to the original records, duplicates can be used in lieu of original records at trial. In addition, Defense will be filing additional Motions, which may be able to be resolved telephonically.
