24 Plaintiff, State of Arizona, by and through its attorney, Matthew J. Smith,

1           1.     That defendant's motion to suppress evidence obtained in the search  
2 that occurred at property belonging to the Fundamentalist Church of Jesus Christ  
3 of Latter-day Saints (FLDS) near El Dorado, Texas (YFZ Ranch) beginning on  
4 April 3, 2008, and continuing thereafter is granted.

6           2.     That the evidence obtained thereby is suppressed and the State agrees  
7 that it will not use any evidence obtained as a result of the search of the YFZ  
8 Ranch, directly or indirectly, in his case-in-chief, during cross-examination of any  
9 called defense witnesses, as rebuttal evidence, or for any purpose whatsoever.


11           3.     That, in light of the foregoing, the hearing on Defendant's Motion to

13 set for February 17 and 18, 2010, is hereby vacated.
