## **Dictation on Sunday, September 4, 2005**

12:47 a.m.

### ***At the Place of Refug R17***

I am at R17 in my room at the big house, having traveled here today from Wichita, Kansas. My last dictation was three days ago, Thursday in the afternoon at 1:10 p.m. at Earth City, or a suburb of St. Louis, Missouri. Continuing that day of September 1.

### **Thursday, September 1, 2005**

The Lord had instructed that I and my ladies, and Isaac and his lady should stay in our motel rooms and not be seen out and about. He instructed that certain movies be watched. And the Lord allowed us to see what was the greatest mockery of God and the plan of salvation I have ever seen; the plan of Lucifer overthrowing the plan of God in their ways of acting and doing.

I had the ladies watch three movies, the great popular movies of the time. There was constant violence. This nation worships satan. We also witnessed more concerning the affects of hurricane Katrina in the Gulf of Mexico states.

There was truly the spirit of the Jaredites among them. The national government is sending in thirty thousand troops. There are thousands upon thousands dead and injured. They are not able to evacuate them. There is a lot of looting and violence, killing. And now there is an order to evacuate the whole city of New Orleans. And the looters who have guns are fighting, shooting at the rescuers. It is a terrible situation. Also the news showed New Orleans as an oil refinery center for the United States where pipe lines ship oil northward as far east and north as New York City, and up to Chicago and over into Colorado. The Lord is doing His work. I had with me, Vicki, Lorraine, and Millie, and Naomie. I did give a training at a certain point showing the ladies the difference of the spirits.

### **Friday, September 2, 2006**

I retired at 3:00 a.m. in the morning and went through the heavenly session until 7:30 a.m. I was shown that I should have Nephi pick up the three ladies and go to R17, and I should go to Wichita

Kansas and witness that place. Truly St. Louis is a dark and wicked place. It must be destroyed. All the time I was there, that was my prayer unto the Lord to deliver the faithful and send forth His judgments upon the wicked to destroy that place.

Friday morning we arose. We had the men get the cars ready, and we arranged so that Nephi could pick up the ladies at another motel room at another motel, and we kept in telephone contact with them during their travels. After Nephi picked up the ladies, we drove to Wichita, Kansas, keeping in phone contact, and thereby looking at the map seeing where they were through their trip. I yearned unto the Lord to know what to do next.

We arrived at 5:30 p.m. at Wichita, Kansas. Naomie and I witnessed some of what that city upholds in their entertainment efforts. Also in the heavenly session, the Lord revealed what that city was like. Again we witnessed great corruption. My inward soul just yearned unto the Lord for the rise of Zion. In our evening prayers I asked the Lord if it was right we could return to the land of refuge and continue His work there, and that He would hold back the enemy, and also sweep the wicked off the land. We retired about midnight.

### **Saturday, September 3, 2005**

I went the heavenly session until 7:30 a.m. The Lord showed me that Wichita, Kansas is a wicked place, where there is a murderous spirit present. None doeth good there. I was shown that I should go to R17, have Nephi Jeffs meet me in Abilene, Texas. So I was being sent back where my enemies are searching for us. I was shown that I had to be very careful when I arrived and not let everyone know at first that I was there. I did not make phone calls, but I pled unto the Lord the whole way there to fight our battles, open they way that we could be protected, and He whispered strong peace to go forward. The Lord named marriages to be performed on Sunday, and that perhaps I could go to the 9:00 a.m. meeting unannounced, just show up.

We read the news paper on the news of the hurricane and its effects. Gas prices jumping very high. Some places over five dollars a gallon. That would be over two dollar rise per gallon, and it will hurt every business, and every people on their money concerns. They are still trying to evacuate

the city of New Orleans. Other cities are completely wiped out; small cities along the coast.

The Lord is doing His work. I yearn that the people would repent, but they will not, so the Lord is having to send His judgments. And yet, the people just curse God and die, and fight each other. The spirit of the Jaredites is among the gentiles. It will be terrible.

We met Nephi at Abilene at 6:30 p.m. and he drove us to R17, arriving at 8:30 p.m. I got in the room at 8:40 p.m. without any of the family knowing. I arranged for Nephi to walk around and have Patricia walk into the area where I was standing in the foyer. And I have had Patricia, Millie, and Ida in with us tonight.

I seek unto the Lord for His will to be made manifest, and reveal the hearts of this people, and

also what must be done, what is holding up this mission. They still do not even have half of the stone on the temple. The Lord has revealed there is a partial falling away among the people at this land of refuge, where they are distracted toward their selfish will, wanting to go visit friends and relatives rather than stay on the mission, talking of certain individuals. The Lord requires oneness after the order of heavenly, and it just takes one person to break that oneness. Oh that this people will awake.

I am willing to atone for this people, yearning unto the Lord to spare them if they can be Zion, touch their hearts with the power of His word, and give the increase needed to accomplish this work. The Lord's will be done. End dictation at 1:00 a.m. in the morning.

Monday, September 5, 2005**

**10:00 p.m.**

*At the Place of Refuge R17*

**Sunday, September 4, 2005**

My last dictation was Saturday night after I arrived here, September 3<sup>rd</sup>, so dictating September 4<sup>th</sup>, Sunday. I seek Heavenly Father's Spirit to be with me, making His record. The Lord took me through the heavenly session until around 7:00 a.m. I was able to have certain ladies greet me, Patricia, Millie, Ida, Naomie. The Lord showed me through the night what message He wanted given in our Sunday morning Meeting. That is all recorded. He told me to not walk into the meeting until after it had started. I had called Brother Wendell Nielsen Friday night and told him what to do for meeting, that I would be calling in, and that they should wait quietly after their opening prayer until I called. The Lord had me go over while nobody was watching and in a manner that my enemies would not see me, going down into a basement door. At 9:18 a.m. I walked into the meeting and took charge. I spoke for an hour and a half, giving the Lord's message. I had Brother Merrill Jessop and then Brother Wendell Nielsen speak. I announced that there would be baptisms on Monday afternoon, and also certain children would be set apart as temple builders.

After the meeting, I had the brethren meet me at noon. And there was performed three sealings. I had Brother Wendell Nielsen say opening prayer. The witnesses were Brother Wendell Nielsen, Merrill Jessop, Brother Joseph Steed was present, and Raymond Jessop, both the counselors of the Bishop. Millie was my scribe at that time. First, Ruth Steed received a resealing to Brother Fredrick Merrill Jessop for time and all eternity, she having been rebaptized and returned to this land. Then Martha Alice Emack, daughter of Mike Emack, was sealed for time and eternity to Joseph Steed, the second counselor to the Bishop here on this land of refuge. Then I had Leroy Steed bring in his niece, Nancy Joanne Steed. I informed her that she was to be sealed to me, which she willingly received. I delegated Brother Wendell Nielsen to be mouth, and there was performed the sealing of

Nancy Joanne Steed to Warren Steed Jeffs for time and eternity.

I then gave a training to the First Presidency with Brother Merrill Jessop's counselors in the Bishopric present, Raymond Jessop and Joseph Steed. And I emphasized to them that the Lord wanted us to have our families one in the order of the Priesthood. I gave training of the prayer of oneness. I emphasized how the Lord is going to choose from among us, and the halfhearted must be removed from this land. And this was eternally serious business, setting ourselves and our families in order. I explained a little more to these brethren about this wicked generation, and what this world was like, and why the judgments must come forth.

After the counselors, Raymond Jessop and Joseph Steed left, I talked to the First Presidency and emphasized again to them and to us that we must be one in our families. And I recommended in their Sunday Schools, they read from about verse 10 on of the revelation dated August 11, 2004, describing the building of the temple and how Zion's Camp should live.

Sunday morning I was shown by the Lord that certain people must not be on this land before I made my appearance. And the Lord had me send away Melvin Steed, Richard Blackmore, and Zane Blackmore. Melvin Steed to return to Short Creek; Richard and Zane Blackmore to return to Canada. I sent the message to tell Brother Merrill, as though I had sent a phone call message that a job well done for these men. They were to return to unite their families and continue in the mission where their families were located. Brother Merrill whispered to me at meeting that he had just barely finished that work before I walked in.

I explained to the First Presidency in our meeting after the General Meeting, when just those two brethren were present, that these three men that were sent away, the Lord had revealed they were yearning to be gone to their families. That was one vital message to the people that there was a falling away taking place on this land of refuge where many people wanted to go back to Short Creek or Canada and visit their relatives, or have their relatives come near so they could go off this land of refuge to visit them. And many were losing

focus and losing the heavenly fire. They were given many trainings, corrections, encouragements, and the training can go on record.

After I talked to the First Presidency, telling them I would be on this land for just a few days and then leave on another errand, I conducted Sunday School with my family with Isaac Jeffs' family present. We listened to singing parts from the children. Then I had Lorraine and Vicki bear testimony, and Martha and Isaac Jeffs in that order bear testimony. Then the Lord had me give a training on the perfection of the love of God sealed within. I was able to be at dinner, sing-song, family prayer at 7:00 p.m. and the 8:00 p.m. night training Sunday night.

I checked on Joy Jessop, Rich Jessop's wife, who is delivering her child here in this home. I checked on her at 9:35 p.m. The Lord showed me that she would be alright, and that the child would be alright. By 10:00 p.m. the child was born – a baby to Richard Samuel Jessop, and Joy Steed Jessop, born in this home, a little boy. Their sixth son with no girls from that mother, yet.

I trained my wife Nancy last night, telling her a small portion of what I go through at night, and why she could not stay with me last night on her wedding night. But she needed to prepare and qualify to be part of the heavenly sessions and not offend the heavenly beings. I asked her if she believed in the administering of angels, and she said, "Yes." Then I said, "To stay with me at night, the Lord must name you, and you must not offend the heavenly powers. You must be believing." She was tired and I sent her to bed in one of the ladies rooms. I also appointed some of the ladies to clean Nephi Jeffs' home so they could move out of this house and I would spread out some of the ladies into those bedrooms, which I am working on. I ate a little and sent Naomie to rest for a time.

About 11:00 p.m. the Lord took me in hand. I quickly got ready for bed. Millie and Ida were in this room, and as I laid down, I told those two ladies, "If you ladies will be fervent, you could witness great things and be a strength to me, and you must not fall asleep. You must be a heavenly strength, exerting great faith. And the Lord took me in hand, and I felt the great weight of the atoning process. The Lord had me come to around

2:30 a.m. and send those ladies out. I later found out Millie stayed awake the whole time praying for me. Ida did fall asleep, and I sent for Naomie. I went through the severity of the atoning process through the night, the Lord showing me to go forward and perform many ordinances this day. And he showed me that I should perform the baptisms tonight by 8:00 p.m. while it was dark; and the people not bring their vehicles so that our enemies would not notice our congregation assembling.

I went over to the school and appointed what classrooms should be for what grades. I told Brother Merrill Jessop I would be up to the temple. We agreed a time of 1:00 p.m. for a crew of men to haul the safes into the vault when I opened it. I also wrote note to Brother Merrill Jessop telling him the names of certain children to be at my waiting room at 2:00 p.m. with their fathers. And I wrote a note to Brother Wendell Nielsen telling him to be present at 2:00 p.m. I asked Brother Merrill in that note to tell the brethren that their children would be baptized at 8:00 p.m. in the evening instead of the afternoon.

I then had Isaac drive me around the temple and then over and I walked through the home built for Nephi Jeffs' family. And then I went into the temple with Millie, Patricia, Brother Merrill Jessop, and Isaac Jeffs. And I on purpose went to every room and examined every room, and truly it was a heavenly joy and a heavenly feeling there. I named a few things that could be repaired. I named where certain bookcases should be hung in certain rooms. I did tell Brother Merrill that the south records room was for the men, and the north records room was for the women. And it is interesting, the women's record room as more file storage space.

We took extra time fixing up the vault, moving the safes in and so I was late for my 2:00 p.m. appointment, and I sent word to meet at 4:00 p.m. At 4:00 p.m. I met with the First Presidency and the children named. And there were set apart as temple builders under the hands of the First Presidency, Leland Richter's young daughter named Rose Richter, Allan Keate's son Jeremiah Keate, and his daughter Zavenda Keate, Joseph Steed's daughter Mary Marie Steed, Merrill Jessop's daughter Marianne Jessop, and four of my

children, Josephine Jeffs, Helaman Jeffs, Ramond Jeffs, and Hannah Jeffs.

After those ordinances were performed, and the brethren had left, I brought Isaac Jeffs brought in and the Lord had me rename his two children, who were the former sons of Nephi Barlow, the sons of Amy Holm Jeffs, now sealed to Isaac Jeffs. The Lord wanted them renamed with Priesthood names. The oldest boy, formerly known as Parker is now named Daniel Holm Jeffs. The other son named Fielding is now named Ephraim Holm Jeffs, the Lord giving those names. I then performed the ordinances of administering through consecrate oil and sealing the anointing and blessing on Ora Jeffs for child delivery, and then Veda Jeffs for child delivery. I was able to go to 7:00 p.m. prayer and gave some instructions to the family, telling them the Lord's message today for me to give them was they must learn the heavenly gentleness of the Spirit of God. That training is on record.

I then went down to the meeting house, going in a side door, I got into the white clothes and joined in the meeting at 8:00 p.m. in the big meeting room. Brother Joseph Steed opened with prayer. I then gave instructions of the Lord, training them the importance of baptism, a training for both parents and children, and that can go in the record.

Then we went downstairs to the baptismal font room, and the Lord had me perform the work of

baptizing thirteen children. Let us name them on this record: First Edmund Allred's son, Brett Winters Allred, Miles Rulon Jessop, Ian Barlow Nielsen, Royce Wayman Nielsen, Wendell Jeffs Nielsen, Fredrick Jessop Nielsen, and SaRoya Nielsen, Neamiah Allred Jeffs, Richard Samuel Jessop Jr., Patricia Jeffs, David Jessop Jeffs, my son, and Esther Rose Jeffs, Marilyn Keate. I returned here. We had a snack with the girls, gave them a few words of training, now going to the temple to close the vault. I thank the Lord for the privilege of going in His sacred house. Many ordinances were performed this day.

I put on record that in the last two weeks there have been three hundred twenty-five children baptized into the church of Jesus Christ of Latter-day Saints and of the Kingdom of God on the earth, confirmed at members. And the children that were confirmed here, were also, in their confirmation ordinance, confirmed at missionaries in the redemption of Zion. The Lord showed me that is what we should do on the lands of refuge. It will be in the Bishop's record who was mouth at each of those confirmations. There have been three hundred twenty-five children baptized, and two rebaptisms. Three hundred twelve children in Short Creek and thirteen children here on this land or refuge baptized and confirmed. So the work of God is growing. End dictation 10:50 p.m.

Wednesday, September 7, 2005**

**9:08 p.m.**

***At the place of Refuge R17***

I seek Heavenly Father's Spirit to be with me, rejoicing in Him. I dictate today, remembering three years ago, this was the day father became so ill. It led into the next day of his passing on. It has now been – tomorrow it will be three years since his passing, and the greatest experiences of my life, the greatest up to that time. Father is near, and since his passing, the Lord and father have made sure that I understood father is near, and he is in that greater state covered with the heavenly fire continually, and I know it. I am here to do the will of my father and thus Heavenly Father, and seek Heavenly Father's Spirit in this dictation.

**Wednesday, September 7, 2005**

I went through the heavenly session shortly after midnight until 4:30 a.m. in that more unconscious state, going through the severity. Around 4:30 a.m., I became conscious in the midst of a revelation and dream the Lord sent to me where he showed me a woman assassin coming on this land to kill me. In this dream, the Lord showed me certain men who professed to be friends and wanted to assist me, and yet they were instruments to help the government and this assassin find me. In particular, there was Ron Rohbock and my brother LeRoy Jeffs. And the Lord showed me also Stanley Jessop was an instrument through which my enemies would try to find me.

I saw without naming every detail, I saw in this dream that I was doing things to help children. And there came a circumstance where some of the people had witnessed me help some certain children, and I was somehow repeating the same experience. They plotted to bring a danger upon children that I had helped before, thinking I would come and help those same children again. I felt the warning that something was amiss, and I stepped forth to help these children again, but before I did, I saw that there were two guards in a vehicle right near by, and as I stepped forth to help these children who needed some help, who needed a blessing, another car pulled up behind the car of the guards. I helped the children, then I walked

over to the car where my guards were, and I said, "This is a strange woman. Get out of your car and make sure she leaves right away. I walked away from the car of the guards, and they weren't able to get out. They hardly comprehended what I said. And as I walked away, this woman got out of her car and was surrounded by the children on this land. And the children were curious, and friendly and telling this woman things. She was putting on a show of putting forth and interest in what they were saying, and then when she saw me, she stepped forth around twenty feet from me, and she took these spikes, these circular star spikes with sharp points and razor blade points with poison on them, and she threw one at me to kill me. And the Lord twisted me to where my clothes caught it, and I recognized that it was a poisonous instrument, a disk in the shape of a star with these razorblade points that if it struck me, it would kill me.

I hurried and handled it carefully through my clothing and dropped it on the ground. I looked at her again. She pulled one out of some sort of pocket in her clothing and flung another one at me. And I was somehow pushed out of the way, and that whizzed past my body, aiming toward my neck or head. When she saw that one missed, she pulled out another one and was just about to throw it when my dream ended. And I sought unto the Lord what this meant, and He showed me that this was a woman assassin that wants to come and kill me, and she will attempt to do this in a quiet way, not even using a gun. And the Lord showed me very openly that the guards on this land are asleep and not prepared, and that I must do something about this, that I can only be on this land if we have an active and awake guard.

I continued in the heavenly session in a conscious state past the time of Good Words with the family. I had some ladies assist me. The Lord directed that I read my mail, also that I talk to my young ladies. I read mail for a time, and then I met with my young ladies from about 9:15 a.m. til 11:00 a.m. All my ladies that are eighteen years old and younger. And they received a very strong training on becoming one with their husband and head. Part of it was recorded. The portion that was not recorded had to do with teaching them the fulness of the law of Sarah in the law of Abraham. I read from the October 16, 2004, revelation in

reading the complete revelation and gave detailed explanation on Celestial morals, the prayer of oneness. And they did received the training of how to assist me in the heavenly session. I was about to have Millie, or Patricia or Naomie, who were present, to bear testimony of the heavenly sessions; instead the Lord stopped me. I excused all but seven. Present were Naomie, Patricia, Ida Vilate, Gloria Anne, young Millie May, and the new wife Nancy Steed Jeffs, and Millie, Mildred Annie Jeffs. There were seven. I gave them a training and offered to Nancy to step forth and show that she received this. And all the ladies joined in and at least outwardly showed a oneness that they would uphold the law. We had circle prayer and then I dismissed them. I read more mail. I did go to lunch prayer and gave a short training to the family. I was warned of the Lord today that I should not go outside, so I have been outside the whole time.

This morning before my 9:15 a.m. meeting, I mapped out the new bedroom arrangements, shuffling most people to new bedrooms through the house. I had Millie post those on the door, and the family has been switching bedrooms. I also organized some job assignments for family members. This afternoon I continued reading my mail. I was to the 5:00 p.m. dinner prayer and gave a few instructions then. These instruction times are recorded. I have been reading the transcript of Sunday School last Sunday, prepare it for a handout for the people. I have been reading my mail.

I was to 7:00 p.m. prayers and gave a twenty minute instruction, yearning the Lord to touch their hearts. I spoke of the violent nature of our enemies and how only the Lord can protect us, and only Zion will remain. I did record that training also. Many wives and children clamored around me, holding onto me, asking many questions. I said goodnights until about 7:40 p.m. I retired to my room. I had Naomie and Patricia go up to the temple to complete the marriage record and archive some files.

As it came to 8:00 p.m. time, I asked the Lord if I should go read to the family, and I was shown that I must not. I told Millie to go tell the family to listen to the August 29, 2005, Good Words training that was recorded, and they did that tonight. I

finished reading the mail from the people at R17, all except the letters from my ladies. I have approved the new song Melanie wrote the music to, and also Mother Kathie wrote the words titled, "Add to Your Faith". I had Kathie write those words, telling her to seek inspiration from the scripture, "Add to your faith, to virtue knowledge, to knowledge temperance, etc."

At about 5:40 p.m. I met with nine ladies in my office and appointed them to be the daily cleaners of the temple. Most of them have received their holy anointings. I later rearranged the schedule. Three per floor, and they do not work on any floors above what they are assigned. I assigned Millie, Patricia, and Ida Vilate, my ladies, to clean the Celestial floor. I assigned Rachel Paula, and Mother Marilyn to clean the second floor. Only those who have had their holy anointings of the ladies should go on the top two floors. So those who clean the top floor can help clean all the lower floors. On the main floor is my sister Nora Jeffs Keate, and Merrill Jessop's two ladies, Lydia Jessop, and Edith Jessop; and they will also clean the basement once a week by mopping it.

I also sent Brother Merrill Jessop a letter telling him the Lord told me, and strongly directed me to increase the security on this land, and that I cannot stay on this land if the guards do not stay alert and awake and active. I sent these notes to him, both about the temple cleaning and about the guard on the land. I have told Isaac Jeffs to have he and Nephi take turns through the night guarding this house.

The judgments of God are going to be terrible for the wrong doers, and the elect will barely escape, but there will be a people prepared for the fulness of Zion. I have had a yearning all day since my talk yesterday, awakening to the reality now, and the Lord answered my prayers where I asked Him what is the condition of the people on this land. The Lord showed me this yesterday, and through the night, that this is an earthly Zion's Camp. Many have lost the heavenly fire.

### **Tuesday, September 6, 2005**

I went through the heavenly session until noon. I reached unto the Lord as I was in the conscious state from about 9:00 a.m. on, who of my ladies was ready to help me. Naomie and Millie assisted

me. But the Lord did not name any others. I was shown in the heavenly session I needed to talk to my young ladies, also I needed to organize the school, and also I needed to explore the land and seek unto the Lord where more houses could be placed on this land.

In the afternoon, I had Isaac drive me over to the storehouse building where Brother Merrill Jessop has added a whole other building, and was going to do a duplicate. I saw that the bulk storage needed to be connected and I made suggestion to the builders that they needed to connect the two buildings with two large garage doors with a passageway enclosed between. The two buildings are about five feet apart. Then they would build a two story addition to the bulk storage area for the clothing store and the sewing establishment. We then drove over the school. I had organized that afternoon, the names of the teachers, and I posted the teachers and their student lists on each door. I talked with Brother Merrill Jessop, and we had a good hour meeting or longer. And I listened to the report about the many things taking place. I was alarmed the night before that there were no workers building the temple just past midnight when I was leaving the temple building, and I told him so. Where are the workers? Why are we not doing a strong push on this. And he went through many details among the brethren, how they have lost their efficiency. So he had directed the men stop work at 11:00 p.m. and be at 5:00 p.m. prayers and back to the job by 6:30 a.m. He described details of trying to inspire the men, encourage the men, and prompt the men to get more done, to be on the job, pleading with some men to be on the job. And after all was said and done, he asked me what the Lord's counsel was. And I said, "Basically, you are explaining that this is an earthly Zion's Camp, and it looks like these men, this crew, though there are individuals that are feeling the heavenly fire, but the crew in general has lost the heavenly fire, and it looks like the Lord's word is going to be fulfilled exactly, we will be brought to our knees when these men's families are persecuted and suffering, even some of their family members killed through the persecutions, and that is when they will wish they had been fervent and fulfilled the labors on time.

I told Brother Merrill I needed to go around and explore the land. I hope to meet with the brethren at 8:00 p.m. and perhaps my speaking to them could help them wake up the need of the greater strong push. Brother Merrill mentioned, perhaps, just maybe they could get done with the rock work on the temple by November 1. And that would be a strong push. That also alarmed me.

As I went away from Brother Merrill, hoping to talk to the brethren to encourage them, a great yearning came upon me, yearning the Lord to spare this people. All along, through all the revelations concerning working as a Zion's Camp in the last year and a half, the Lord has named how to work as a Zion's Camp, to reach for the strength of heaven, and feel the heavenly fire. And we have been warned we will be scourged and brought to our knees, some people removed if we do not earn that heavenly oneness and exert that oneness through the powers of heaven.

So I had Isaac drive Millie and I around the land. We drove around the temple again. I did walk the land at certain places east of the meeting house, east of the old storehouse, south of the old storehouse, and then the lots just north of the temple and south of the cemetery. And I marked on the map fourteen places where houses could be built. I counted how many houses are built, there are eleven; adding that up that would be twenty-five, and then I remembered the Lord had told me before we built any houses here we would have about twenty five homes. Now I remember there are thirteen houses with the duplex and original south house by the old storehouse. We will see what the Lord allows us to do.

I told Brother Merrill in my afternoon meeting with him, that Lehi Jeffs Allred family would move to this land, also I need to remember him David Fischer Jessop family will move here, and also David W. Jessop family will move to this land. And a house was to be built for Isaac, Seth, and two duplexes for those other families to share. I told Brother Merrill again, we must seek for the heavenly fire in this mission.

I had Isaac drive me out to the rock quarry, and I saw they were expanding the rock quarry one hundred thirty feet to the east, and that it would be as wide as the rest of the rock quarry. In my letters

from the brethren working on rock, they have described how the Lord has blessed them with more a yield of good cut stones from each block. I thank the Lord for that report. They have testified how the Lord has healed the stone and made it work.

I talked to Leland Richter as I drove around the temple last night. He told me about forty percent of the rock is up on the outside of the temple. Brother Merrill described in his meeting with me that he had held off large crews of men laying rock while they took time to cut rock at the rock saws and process it. I just emphasized to Brother Merrill again that rock on the temple is the priority. We should be pushing that. But I recognized knowing Brother Merrill's heart is right, he is dealing with a halfhearted Zion's Camp. Many are relaxing their faith. Some are fervent, and carrying the rest along with the First Presidency carrying the people, the Lord doing it. This has weighed upon me since my discussion with Brother Merrill as I have seen the Lord answer my prayers where I asked him what is the condition of this Zion's Camp, and I can see we are demanding the harder experience.

Brother Merrill discussed with me also, when I asked are they visiting the houses and seeing to their needs, he said many people are asking for things they don't need. And I explained that he and his assistants should not go the women to ask for special needs, but the husbands, the father of the home should be approached by their families for special needs and help govern the appetites of their families. He explained how even some of the men were buying four hundred dollar boots, and bottles of fifty dollar cologne, unnecessary. I

told him I hope to speak with the brethren at 8:00 p.m. and he needs to tell them to govern their appetites, and govern their families' appetites. These stories reminded me of the first Zion's Camp, how Heber C. Kimball saw people not blessing one another when the people were sick, seeking things for themselves that others could use and not blessing others; yet I know there are people here on this mission doing the job right.

I was able to get back to the house and then be at the 8:00 p.m. prayer time and reading, and I read a sermon of father's in 1979, volume four, on the gift of revelation and the cleanup, sifting that is taking place, showing the family how it applied to us. We had prayer last night, and I had quietly sent a lady to tell all my ladies twenty-one years old and younger to meet with me at 9:00 p.m. It came to 9:10 p.m. and the Lord showed me that I must not meet with them. So I sent them out. I sent for my new wife, and Naomie, Patricia, Millie, Ida, and Nancy the new wife met with me. I worked on Nancy a little to get her close, teaching her, explaining things to her, and she is doing well. And today, she advanced quickly, getting closer than ever.

From about 12:30 a.m. until 1:30 a.m. in the morning this morning, I had Naomie and Patricia rubbing me my sore back. Then Patricia went out about 1:30 a.m. I have dictated today. I am seeking of the Lord to know what to do next. The Lord has kept me from going to the temple today. I am yearning He will open the way in every way. God bless the work of God. End dictation around 9:40 p.m.

## Dictation on Thursday, September 8, 2005

9:30 a.m.

### *At the Place of Refuge*

Thank our Heavenly Father that He and father and others are near. The Lord is determined that this mission succeed. He is judging His people. I seek Heavenly Father's Spirit to be with me, to keep the sacred record. This is dictation at this time. I have been through the heavenly session through the night. I thank the Lord for this privilege to be part of the redemption of Zion, to have whatever part He would have me do. And that He is guiding this work.

The Lord had previously call on the ladies on this land for confessions of immoral desires toward men that they were not sealed to. I had called R17, had the brethren gathered. At that time I read from the February 14, 2004, revelation, calling on the men to make confessions if they have partaken of that evil again. I received letters from some of the people, men and women, when I was in hiding when the ladies came to see me to receive training. In one letter in particular was from Joseph Newel Jessop. He was very concerned about himself. In any letters of confession I had received from him, in every one he named his weakness and sin of having immoral desires toward certain ladies on this land, in particular my daughters and wives. In this letter I read that he wrote at the end of August, he confessed again of having immoral desires toward Mother Asenith, father's wife, now my wife in this life, and Joy Jessop Nielsen, Uncle Fred's wife.

This morning, the Lord has kept me hand. I was alert at 5:00 a.m. and took me in session, and did not let me go to the family Good Words. I was alert at 6:30 a.m. and had Naomie rehearse what the Lord had me say out loud and what she witnessed. The Lord has kept me in hand. I have been reaching to understand is there something more I must do.

A few minutes ago, the Lord brought me out of the unconscious state. I say it is a conscious state, in communication with the heavens, He gave me revelation in the form of a dream where I was traveling through opposition, trying to get to

where father was, and I finally arrived at a building where he was sitting at a desk, and there was present, as I walked in, to father's right, not right next to the desk, Brother Merrill Jessop and behind him his son Joseph. I walked up and sat in the chair next the desk and father was very concerned. I looked over at father and there was Joseph Newel Jessop sitting right in front of him. And father appeared to be looking through a record, and I looked over at Brother Merrill and Joseph was sitting over behind him. I asked, "What should I do and know father?" but he was busy in this case. I looked at Brother Merrill and Brother Merrill looked at me and said, "I know it is all individual. I know it is all individual." I looked over at father, and he turned his back on Joseph, and he had Joseph walk around in front of him, sit down on a chair, and it was as though he was looking at a record, and he looked at Joseph and said, "I don't want to look at your face." Then Joseph went behind him, and then father turned to me and said, "Why aren't you doing something about this?" In seeking the Lord, I was reminded about his confession letter. I know I had Mother Asenith change from storehouse to another where I had gone out and about two days ago, there was Mother Paula, Mother Asenith, and Bonnie, bubbly and energetic, working very hard, getting the job done, right with Joseph Jessop. He was at the storehouse where they were working. When I came by, he would not come over to see me. Normally he runs up to meet me. So I beckoned for him and he came over and shook hands. Oh that this people would realize they are being watched.

I have now dictated a letter to Joseph to remain in his living quarters, write me a full confession letter so his case can be considered on this issue of immoral desires towards the ladies who are not sealed to him. I have called Asenith, Bonnie, and Carla away from the storehouse areas into my waiting room to be away from that situation. It was other women before. And I do not remember who they are right now. One was my daughter Lenora and my daughter Teresa. Others involved with his feelings were some of my ladies married to me. I thank the Lord for allowing father to come. The look on father's face was stern and determined, and concerned that the evil powers

were coming on this land. And he had explained it to Brother Merrill before I got there in this dream, the devil was trying to come among us. So father has taken a personal hand in this.

I had Naomie and Patricia go and update the marriage record and they returned around 9:30 p.m. I had a few ladies with me. We retired just past midnight. I am seeking of the Lord when He wants me to give this message to the men. Everything the Lord is having me say about this Zion's Camp shows there has been a falling away taken place, a lightening up, a losing the heavenly fire. The Lord wants me to turn this around. He wants the laborers to turn this around. But one thing for sure, if the works are partaking of immoral desires toward those who don't belong to them, they will lose Priesthood. Many men have fallen from treating my father's ladies that way.

The Lord has had patience with this man, and all of us. The Lord bless us, and guide me to do His will.

A fine line between purity and not being pure is in your thoughts, and feelings. Do all we do through prayer and the Spirit of God, giving our all to those appointed, beginning with dwelling in the Lord's will. Righteousness and purity is to learn the will of God and do His will through His power to glorify Him. We are to enjoy His gifts and blessings, but through His power, and to do His will; in other words, be directable. The Lord is choosing from among my ladies who will live this way. Praise God from whom all blessings flow. End dictation at 9:40 a.m. I make note this is the anniversary of father's passing. And father is here. It is that simple. Thank God for such love toward us. End dictation.

## Dictation on Saturday, September 10, 2005

9:50 a.m.

### *At the Place of Refuge R17*

Seeking Heavenly Father's Spirit to be with me. My last dictation was Thursday morning as I was in the heavenly session, which was September 8, the anniversary of father's passing, his graduation. My thoughts were upon father greatly that day, and father was here, is here often. The Lord is near and the Prophets come.

The Lord kept me in the heavenly session until 3:30 a.m. in a greater capacity. I was actually involved in the heavenly sessions in varying degrees through all day Thursday, through Thursday night into Friday morning. I thank the Lord for this grand experience. He is increasing the intensity of these heavenly sessions. He is allowing the greater atonement and suffering. I have been seeking unto Him to hold not back.

When I was more able to move around, I fulfilled the word of the Lord where He judged Joseph Newel Jessop. I wrote a letter to Brother Merrill Jessop, the Bishop, that he and his counselors should read to Joseph, and I told Joseph in that letter that he does not hold Priesthood, his family is released, and he is released from this mission. He is called to repentance, and work toward rebaptism. I told him I loved him, and he should consider this a great act of love from Heavenly Father to deliver him from his sins. I put on record that he did send me his letter. He did confess to what the Lord had shown me, immorality toward the daughters of Zion. My wives, my daughters, even his own father's young wives, Brother Wendell's wives and daughter and others. He was overcome because he was dishonest before the Lord. But I also put on record that he was honest in his confession. The Lord has shown me since that He will bless this young man to be restored through baptism if he will continue fervent unto God.

I sent him to work with Ernest Jessop, his brother. He is working for Fred Jessop another brother. I sought to go meet with the family and the people. The Lord took me in session at 6:40 p.m. very strongly. The family meets at 7:00 p.m.

and the men meet at 8:00 p.m. But the Lord kept me right in session til 9:30 p.m. At times paralyzed, other times unconscious, giving dreams and revelations to me. Naomie was present. I voiced then what the Lord has been showing me lately, that Naomie would stay. I would be taking others. The Lord had me name Patricia and Millie to go on this next travel with me.

I went through the heavenly session and was kept in hand past the Good Words time. I was shown that I should take care of some marriages, meet with the First Presidency also, and also name some jobs for certain individuals and give corrections and training to individuals, then I would be leaving at 4:00 a.m. in the morning Saturday morning.

I was kept in hand by the Lord until around 5:30 p.m. I was able to be up, and get dressed into my Sunday clothes, my suit. I had a message sent to the First Presidency and others to meet at 6:30 p.m. which I did. I put on record that between 6:30 p.m. and 7:30 p.m. two marriages were performed along with some training to the individuals. Jacob Richard Allred received Priscilla Jessop, Uncle Fred's daughter, and then Dan Barlow Jessop received Sarah Elizabeth Jessop, Uncle Fred's daughter through his wife Amy. Brother Wendell Nielsen was present and Brother Merrill were present as witnesses, also my brother Isaac Jeffs. Before we performed these ordinances, I had Seth Jeffs and Isaac Jeffs witnesses while the First Presidency laid our hands on Dan Barlow Jessop and conferred the Melchizedek Priesthood and ordained him to the office of elder. He had to receive that before he could be married.

After the weddings, there was a meeting of the First Presidency that was recorded and should go in the record. I informed these brethren that I to leave by 4:00 a.m. in the morning, and as far as I was able to see, the Lord has told me I would not be returning to this land until the temple was complete, along with the temple lot and annex. They must hasten. I explained to them how we must do all we do by the power of the Spirit of God. And I told them what to train the people, to beware of falling away into earthly complacency, losing focus. Once again this is recorded and should go in the record.

I then talked to Brother Merrill Jessop on issues concerning this mission. He asked me about certain designs of the rock on the east end of the temple. I told him I would take it up with the Lord. He also asked me if the big rock quarry could be used as the sewer pond, and I said I will have to inquire on that because that is a sacred site, and I seek the Lord for his guidance.

With Brother Merrill Jessop present, I called in Aunt Veda Johnson, Mother Gloria Jeffs, and Mother Kathie Jeffs. I told them the Lord gave them the job to quickly write an English program for our students to use for first grade on up, and to get the first grade done before they go onto second grade and so forth. They are also to do a reading program for second, third, and fifth grades. I told my brother Seth Jeffs to get two computers set up for Mother Kathie and Aunt Veda to use. Mother Gloria will be an advisor I that project.

I also went over with the First Presidency, going back to that meeting, and described about the handling of Joseph Newel Jessop. And I gave Brother Merrill Jessop the message of the Lord that the Lord recognized that he made an honest confession, and if he will be fervent and honest in his repentance, he could receive rebaptism and Priesthood blessings soon. I told Brother Merrill to contact Joseph and tell him this.

I then had a private interview with Mother Kathie, my wife, father's wife. I gave her the strong training to beware being a self revelator, which means she thinks she is living righteously, but she is not. She thinks she is dwelling in the will of God, but she is not. I told her that her counseling other people writing her many letters, and opinions and even writing letters to the Prophets, myself and father of her opinion of things was being a self revelator. She has written many letters of counseling to people she had no authority to do.

I then met with my younger ladies and told them they were to have a sewing class. I had informed Sylvia Jessop Nielsen to be the teacher in the school building for eighth grade and high school, and I told Esther, my wife, to be the teacher for my younger ladies for sewing, one hour per day. I have organized the school schedule and told them to not start school until a week later than the

regular school. The regular school for the children will start Monday, September 12. The Lord has warned me that we must do this so that the government powers do not come against us.

After I talked to my young ladies I got ready, changed out of my suit into my work clothes so I would look like one of the workers, and I took Naomie and Patricia up to the temple to do final archiving. And I was able to visit most areas in the temple. There is truly a hallowed, heavenly Spirit in that sacred building. I stood at the font and offered prayer that that could be used for the living and the dead. In my office I had Naomie and Patricia kneel down with me as I offered a rededication prayer of that building and the temple lot, that it would yet be finished, accepted, and used for the faithful by the Lord, and the Lord's presence come there. We feel the heavenly influence there already, and we keep everyone out. I told Brother Merrill that only those who have received their holy anointings should go in there unless there is some emergency repair. And I cancelled the cleaning crew for now, only having Millie, Patricia, and Ida, Brother Merrill and his two counselors who have received the holy anointings should go in there.

The Lord directed that Naomie stay and do transcribing and training for me with the ladies, that I will take Patricia and Millie, Mildred Annie Jessop Jeffs. I have three Millies so I have to specify – four Millies with a little daughter named Millie

We returned to this house around 11:30 p.m. and then made preparations to leave by 4:00 a.m. I had Annette give me a haircut. The Lord took me into the heavenly session around 2:00 a.m. in the morning, and I was suddenly alert at 3:30 a.m., but under great distress. I was shocked that I had been prompted to arise since we were leaving at 4:00 a.m., but the Lord had me voice that we would be leaving at noon and that I need to read the transcripts of the meetings first, and also He would protect us right at noon so that our enemies could not see us.

I was kept in a severe session. And I say with rejoicing, and yet I recognize that this is getting stronger and stronger. It was a distress to even touch anything, even my body was a distress to me.
