AFFIDAVIT

I, J. NICK HANNA, Texas Ranger, in the city of San Angelo, in the State of Texas,
United States of America, MAKE OATH AND SAY THAT:

1. I have been a commissioned peace officer with the Texas Ranger Division of the Texas Department of Public Safety since September 1, 2003, and as such have personal knowledge of the matters deposed to in this Affidavit, save and except where stated to be based upon information and belief, and where so stated, I verily believe what is stated to be true.
2. This is the second affidavit that I have sworn in these proceedings. In my first affidavit, sworn March 2, 2011, I explained that on April 3 through 9, 2008, peace officers of the State of Texas executed two search warrants at the Yearning For Zion ("YFZ") Ranch

and that I was among the original group of peace officers that entered onto the YFZ Ranch on April 3, 2008. I remained on the YFZ Ranch daily during the execution of the warrants. One of my assignments from early in the investigation was to act as case manager and an evidence custodian

3. In this affidavit, like in my first affidavit, I refer to the documents that we seized from the YFZ Ranch, pursuant to the warrants, as the FLDS Records. In my first affidavit I indicated that I was aware of additional FLDS Records relating to "marriages" between members of the FLDS that likely involve Canadians. I am unable to search the voluminous FLDS records for all records that may have a Canadian connection, I have, however attached Marriage Records from the FLDS Records, that have been requested and cover the time span from 1990 – 2004. I refer to the females referenced in these Marriage Records as Child O - Child EE.
4. In this affidavit I correct two errors from my first affidavit:
 - 1) Exhibit E to my first affidavit is missing page 675. Attached to this affidavit as Exhibit "A" is a copy of the missing page 675 from Exhibit "A";
 - 2) Paragraph 57 from my first affidavit should read "Children A-N" not "Children A-S" as set out in the last sentence.

Marriage in 1990

5. Attached to my affidavit and marked as Exhibit "B" is the Marriage Record for Child "O". This Marriage Record indicates that she was married for "Time and Eternity" on July 2, 1990 in Spokane, Washington. Winston Blackmore is among the three witnesses listed on the Marriage Record. According to the Marriage Record, the marriage was performed by President Rulon T. Jeffs.

Marriage in 1996

6. Attached to my affidavit and marked as Exhibit "C" is the Marriage Record for Child "P". This Marriage Record indicates that she was married for "Time and Eternity" on August 31, 1996 in Lister, B.C. The wife's father is listed as one of the witnesses on the

Marriage Record. According to the Marriage Record, the marriage was performed by President Rulon T. Jeffs.

Marriages in 1998

7. Attached to my affidavit and marked as Exhibit "D" is the Marriage Record for Child "Q". This Marriage Record indicates that she was married for "Time and Eternity" on October 9, 1998 in Hildale, Utah. The Marriage Record indicates that Child Q was married to a Blackmore. According to the Marriage Record, the marriage was performed by U. Rulon T. Jeffs.
8. Attached to my affidavit and marked as Exhibit "E" is the Marriage Record for Child "R". This Marriage Record indicates that she was married for "Time and Eternity" on October 20, 1998 in Sandy, Utah. Winston Blackmore is among the three witnesses listed on the Marriage Record. The Marriage Record also records Winston Kaye Blackmore as the father of Child R. According to the Marriage Record, the marriage was performed by Warren S. Jeffs as mouth with President Rulon T. Jeffs present.

Marriages in 1999

9. Attached to my affidavit and marked as Exhibit "F" is the Marriage Record for Child "S". This Marriage Record indicates that she was married for "Time and Eternity" on January 30, 1999 in Salt Lake City, Utah. The Marriage Record indicates that Child S was married to a Blackmore. According to the Marriage Record, the marriage was performed by Warren Steed Jeffs.
10. Attached to my affidavit and marked as Exhibit "G" is the Marriage Record for Child "T". This Marriage Record indicates that she was married for "Time and Eternity" on January 30, 1999 at Uncle Woodruff Seed's Home SL (I believe that "SL" stands for Salt Lake City). The father of Child T is listed as one of the witnesses on the Marriage Record. According to the Marriage Record, the marriage was performed by Uncle Warren Jeffs.
11. Attached to my affidavit and marked as Exhibit "H" is the Marriage Record for Child "U". This Marriage Record indicates that she was married for "Time and Eternity" on

February 20, 1999 in Sandy, Utah to Winston Kaye Blackmore. According to the Marriage Record, the marriage was performed by Warren S. Jeffs as mouth with President Rulon T. Jeffs present.

12. Attached to my affidavit and marked as Exhibit "I" is the Marriage Record for Child "V". This Marriage Record indicates that she was married for "Time and Eternity" on April 11, 1999 in Hildale, Utah to Warren Steed Jeffs. I believe that the father of Child V is also the father of Child C (referred to in my first affidavit). The father of Child V is listed as a witness to the marriage on the Marriage Record. According to the Marriage Record, the marriage was performed by President Rulon T. Jeffs as mouth.
13. Attached to my affidavit and marked as Exhibit "J" is the Marriage Record for Child "W". This Marriage Record indicates that she was married for "Time and Eternity" on April 11, 1999 in Hildale, Utah to Warren Steed Jeffs. I believe that the father of Child W is also the father of Child V and Child C. The father of Child W is listed on the Marriage Record as a witness to the marriage. According to the Marriage Record, the marriage was performed by President Rulon T. Jeffs as mouth.
14. Attached to my affidavit and marked as Exhibit "K" is the Marriage Record for Child "X". This Marriage Record indicates that she was married for "Time and Eternity" on April 11, 1999 in Colorado City. Winston Blackmore is among the three witnesses listed on the Marriage Record. According to the Marriage Record, the marriage was performed by Warren Jeffs.
15. Attached to my affidavit and marked as Exhibit "L" is the Marriage Record for Child "Y". This Marriage Record indicates that she was married for "Time and Eternity" on April 11, 1999 in Hildale, Utah. The Marriage Record indicates that Child Y was married to a Blackmore and that the father of the husband is listed as one of the witnesses. According to the Marriage Record, the marriage was performed by President Rulon T. Jeffs.
16. Attached to my affidavit and marked as Exhibit "M" is the Marriage Record for Child "Z". This Marriage Record indicates that she was married for "Time and Eternity" on

November 16, 1999 in Hildale, Utah. Jim Oler is listed as a witness in the Marriage Record. According to the Marriage Record, the marriage was performed by Warren S. Jeffs.

Marriages in 2000

17. Attached to my affidavit and marked as Exhibit "N" is the Marriage Record for Child "AA". This Marriage Record indicates that she was married for "Time and Eternity" on April 18, 2000 in Colorado City, Arizona. The Marriage Record indicates that Child AA was married to an Oler. The Marriage Record also records Winston Kaye Blackmore as a father of Child AA. According to the Marriage Record, the marriage was performed by Warren Jeffs.
18. Attached to my affidavit and marked as Exhibit "O" is the Marriage Record for Child "BB". This Marriage Record indicates that she was married for "Time and Eternity" on April 29, 2000 in British Columbia, Canada. Winston Blackmore is listed as one of the two witnesses. According to the Marriage Record, the marriage was performed by Warren S. Jeffs.
19. Attached to my affidavit and marked as Exhibit "P" is the Marriage Record for Child "CC". This Marriage Record indicates that she was married for "Time and Eternity" on April 29, 2000 in Lister, Canada. "Winston" is listed as one of the three witnesses on the Marriage Record. The Marriage Record also records Winston Kaye Blackmore as the father of Child CC. According to the Marriage Record, the marriage was performed by Warren S. Jeffs.


Marriage in 2003

20. Attached to my affidavit and marked as Exhibit "Q" is the Marriage Record for Child "DD". This Marriage Record indicates that she was married for "Time and Eternity" on December 20, 2003 in Hildale, Utah. The Marriage Record indicates that Child DD was married to a Blackmore. According to the Marriage Record, the marriage was performed by President Warren S. Jeffs as mouth.

Marriage in 2004



This Marriage Record indicates that she was married for "Time and Eternity" on January 18, 2004 in Hildale, Utah. The Marriage Record indicates that Child EE was married to an Oler. According to the Marriage Record, the marriage was performed by President Warren S. Jeffs as mouth.

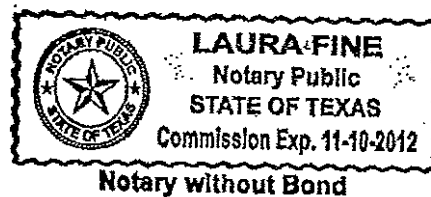
